A) Delegate Terms

2. If for any reason the conference is cancelled or changed, our liability in that instance shall be strictly limited to the amount paid for the ticket/s to the event.
3. Under exceptional circumstances and up to three (3) months prior to the date of a Private Equity Insights event, we reserve the right to reschedule its date by informing each delegate of such change. Should any delegate be unable to attend the event on the rescheduled date, a coupon for the value paid will be provided to the delegate. 4. Refunds will be issued under the following conditions:
 - 100% refund of the amount paid up until three (3) months before the date of the conference;
 - 90% refund of the amount paid up until one (1) month before the date of the conference.

5. No refunds will be granted for cancellations made less than thirty (30) days prior to the date of the conference.
